

# NO GLYPHOSATE

### DIRECTIONS FOR USE

Pour contents into a conventional sprayer. A minimum interval of 7 days must be observed between applications. It is recommended to wear gloves when decanting this product into a sprayer applicator, and also it is good practice to wear gloves when applying this product, although this is not a requirement.

### WHEN TO USE

Best results are achieved against moss and small weeds less than 10 cm high. Ideally spray in spring and repeat as necessary over the growing season, up to a maximum of 6 applications per year.

### WHERE TO USE

Use around unplanted areas of the garden, around buildings on paths, drives and tarmac, and in similar situations where weed or moss control is required. Keep spray off vegetables, flowers, shrubs and lawns.

### HOW TO USE

Apply on a dry day, when rain is not expected. Rain after spraying may wash spray from leaves leading to a poor result. Keep people and animals off treated area until spray has dried. Apply at no more than 100ml/m<sup>2</sup>. Pack treats a maximum of 50 m<sup>2</sup>. Applied at this rate moss, leaves and stems are usually fully wetted. Repeat after 14 days on surviving moss or weeds, when fresh growth is seen. There are no residual effects of Hytrol No Glyphosate Naturally Biodegradable Ready-to-use Weedkiller in the soil. Sowing or planting may be undertaken as soon as the weeds or moss have died. Use of Hytrol No Glyphosate Naturally Biodegradable Ready-to-use Weedkiller make cause some surfaces to become slippery for a short time after application.

### ENVIRONMENTAL PROTECTION

To protect bees and pollinating insects do not apply when plants are in flower. Do not use where bees are actively foraging. Do not apply when flowering weeds are present. Risk to non-target insects or other arthropods. Dangerous to bees. Do not apply where rainfall is expected within 6 hours of application. Do not empty into drains. Do not contaminate water with the product or its container. Direct spray away from ponds and other surface water bodies.
